- The Study Loan (SL) is a means-tested Government loan scheme, and complements the Tuition Fee Loan (TFL). The SL provides loans to cover up to the remaining 10% of tuition fees not covered by the TFL.
- Please ensure that you have submitted your online Study Loan application together with all required supporting documents.
- Applications without supporting documents will be deemed as incomplete and will not be processed. All documents must reach Singapore University of Social Sciences by the stipulated deadline<sup>#</sup>. 3.
