Notes:

- 1) The subsidised fees for Singapore Citizens (SC) and Singaporean Permanent Residents (SPR) exclude GST, which is separately subsidised by the government. The fees for Unsubsidised Students without Tuition Grant are inclusive of prevailing GST.
- 2) The tuition fee payable each semester is dependent on the number of courses the student takes in each semester. The tuition fee does not include textbooks and fee for other items specified by Singapore University of Social Sciences (SUSS) from time to time.
- 3) All Law students will pay an annual miscellaneous fee of S\$200.00 (subject to prevailing GST). The miscellaneous fee consists of items such as CLASS copyright licensing fees,

- 4) National Servicemen will pay the respective tuition fees (along with any increase in tuition fees) based on the year in which they were offered a place in SUSS for which they had accepted.
- 5) Singapore Permanent Resident students are required to sign the Tuition Grant Agreement with the MOE if they choose to opt for Tuition Grant Scheme (TGS). Details will be provided after enrolment.
- 6) The SkillsFuture Credit aims to encourage individuals to take ownership of their skills development and lifelong learning. All Singapore Citizens (SCs) aged 25 and above will receive an opening Credit of S\$500 that does not expire. On 1 Oct 2020, the Government provided a one-off SkillsFuture Credit top-up of S\$500 for eligible SCs aged 25 and above as at 31 Dec 2020. This top-up will expire in five years (on 31 December 2025). SC students may use both the opening SkillsFuture Credit and the one-off SkillsFuture Credit top-up to pay for eligible courses, on top of existing Government course subsidies.
